- 2. Voter ID Card: You can apply for a Voter ID Card online through the National Voter's Service Portal: https://www.nvsp.in/
- 3. PAN Card: You can apply for a PAN Card online through the NSDL website: https://www.onlineservices.nsdl.com/paam/endUserRegisterContact.html; if you have a Pan and need a new PAN, you can order online here by paying nominal fee-here. The charges for applying for PAN is Rs. 91 (Excluding Goods and Services tax) for Indian communication address
- 4. Passport: You can apply for a passport online by visiting the Passport Seva website: https://portal2.passportindia.gov.in/AppOnlineProject/welcomeLink
- 5. **Driving License**: You can apply for a driving license online through the Sarathi website: https://parivahan.gov.in/sarathiservicecov10/newLLDet.do
- 6. **Bank Account**: You can open a bank account online through the websites of most major banks in India.
- 7. **Health Insurance**: You can purchase health insurance online from various insurance companies in India.
- 8. Mobile Phone: You can purchase a mobile phone online from various e-commerce websites in India.
- 9. **Emergency Contact List**: You can create an emergency contact list on your phone or in a physical notebook to have on hand in case of emergencies.
